**Authorized Surveyors** employed by appointed Classification Societies are authorized to carry out survey or inspection and approve plans of the following classes of vessels.

Notes

1. 'Initial Survey' and 'Periodical Survey' are defined in the "Code of Practice – Safety Standards for Class I or II or III or IV Vessels". (Refer to G.N.1134 of 2017 gazetted on 3 March 2017)
2. 'Plan Approval' means the approval of any plan in respect of a Local Vessel which is required to be approved by sections 7 to 14 of the Merchant Shipping (Local Vessels) (Safety and Survey) Regulation (Cap 548 sub leg G).
3. Class I, II, III or IV vessel has the same meaning as defined under the Merchant Shipping (Local Vessels) (Certification and Licensing) Regulation (Cap 548 sub leg D).

Remarks

- (i) Final Inspection defined in "Code of Practice" for Class I or Class II or Class IV vessels shall be conducted by MD officers for vessels listed as follows:
  - a. Class I vessels;
  - b. Class II oil tankers, dangerous goods carriers, noxious liquid substances carriers and any vessels intended for carrying cargoes of hazardous nature;
  - c. Class IV vessels of more than 150 GT or carrying more than 60 passengers.

For any class IV vessel licensed to carry not more than 60 passengers which is let for hire or reward, a Certificate of Inspection will be issued directly by an Authorized Surveyor; and for any vessel listed in (i)(a), (b) and (c) above, a declaration of survey covering plan approval and/or survey except final inspection items will be issued to Marine Department by the Authorized Surveyor after satisfactory completion of necessary approval of plans, survey.

- (ii) The Scope of Services includes plan approval and survey for the modification of Class I, II, III and Class IV vessels.
- (iii) The Scope of Services does not include any Class IV vessel of novel construction.

- I. **Authorized Surveyors** are authorized to carry out survey or inspection and approve plans of the following classes of vessels.

- (1) 'Class II or III or IV vessel' has the same meaning as defined under the Merchant Shipping (Local Vessels) (Certification and Licensing) Regulation (Cap 548 sub leg D)
- (2) 'high risk vessels' in respect of Class II vessels means oil tankers, dangerous goods carriers, noxious liquid substances carriers, and any vessels intended for carrying cargoes of hazardous nature
- (3) 'Initial Survey' and 'Periodical Survey' are defined in the 'Code of Practice – Safety Standards for Class I, II and III Vessels' and 'Code of Practice – Safety Standards for Class IV Vessels'
- (4) 'Plan Approval' means the approval of any plan in respect of a Local Vessel which is required to be approved by sections 7 to 14 of the Merchant Shipping (Local Vessels) (Safety and Survey) Regulation (Cap 548 sub leg G)

Remarks

- (i) Class IV vessels in this Annex refers to Class IV vessels that are (to be) licensed to carry not more than 60 passengers and intending to engage in letting for hire or reward (excluding those exceeding 150 gross tonnage or novel type). A Certificate of Inspection will be issued directly by an authorized surveyor or authorized organization after satisfactory completion of necessary approval of plans, survey and inspection.
- (ii) The scope of services also includes plan approval and survey or inspection for the modification of Class II (other than high risk vessels), III & IV local vessels.
